

Office Space Review is Underway

American Stores Company is continuing to focus their efforts on reducing expenses in all areas of the business. As part of the company's ongoing commitment to become more efficient as a single operating company, a project team has been assigned to evaluate expenses related to excess office space in Chicago, Philadelphia, and Southern California.

Marty Scholtens, chief operating officer - retail, and Steve Mannschreck, chief human resources officer, are leading a review of office space and related costs. They will be developing a consolidation plan and timeline. As soon as it is completed, the office space plan will be communicated.

Excess office space has been

created throughout our company with associates relocating as a result of our major consolidation plans.

The procurement consolidation plan is currently underway. Other consolidation efforts that have been or are currently being implemented are in IT, accounting, benefits, payroll, and risk management.

While there is still a great deal of work to do, it has been decided that associates from 2100 and 2107 will relocate to 1818, 3030, and Melrose Park. It has also been decided that associates from the Anaheim office will relocate to Buena Park and Ontario. The placement of specific functional departments has not yet been determined. As these decisions are made, every effort will be made

to work quickly and to locate departments that need to work together in the same facility. The company plans to continue to operate 1818 at least until the new American Stores office building in Salt Lake City is completed in early 1998. The lease on the Oak Brook Education Center expires in May 1997. At that time, we will evaluate our lease options as well as alternate locations for our educational programs.

American Stores Company feels that this small but necessary change will contribute to making us more efficient as a single operating company.

Time Has Run Out!

As we all know, effective January 20, 1996, the new "847" area code was introduced to suburban Cook County north of the Chicago city limits, most of Lake County, the portion of McHenry County currently in 708, and to the northern portion of Kane County.

To help ease the transition of the new area code, Ameritech allowed both the new and old area code to work for an extended period. As of Friday, April 19, the three month "permissive dialing period" ended. You will no longer be able to use the old "708" area code when calling the areas that were affected by the area code change.
